Hon<sup>r</sup>. &c<sup>a</sup>. will permit Us to tell you, that even this Interpretation of Yo<sup>r</sup> : differs greatly from y<sup>e</sup>. Masters to give any Severe orders however Yo<sup>r</sup>. Hon<sup>r</sup>. &c<sup>a</sup>. will give Us leave to guess that Yo<sup>r</sup>. representations home about Surat have been pretty Much like those about Bussero where You were so extreemly kind, as to desire y<sup>e</sup>. Sole trade for Your selves, & indeed y<sup>e</sup>. Representations to y<sup>e</sup>. Comp<sup>y</sup>. that our Supracargos to Surat are a detriment to their Affairs there looks so like an endeavor to get either y<sup>e</sup>. Sole trade or y<sup>e</sup>. whole Commission of our trade into Your own hands that we must Venture to Say we Apprehend it was more Yo<sup>r</sup>. own Private Interest than y<sup>e</sup>. Companys that has occasioned these disputes.

Nor can we find out how our Supracargo's selling their goods [at] Surat, should any ways hurt y<sup>e</sup>. Compa<sup>y</sup>. Hon<sup>r</sup>. or Interest: but rather they pay y<sup>e</sup>. French y<sup>e</sup>. Moors Armenians, Malabars from all y<sup>e</sup>. Coast [ . . . ] y<sup>e</sup>. English from Bengall do more bussiness there, than ourselves & so would you, if you had not better convenience at home. At Syam, we have no Factory & what little [ . . . ] more than Bengall & Bombay proceeds from y<sup>e</sup>. Kings [Sent] a Ship to Us every year on w<sup>ch</sup>. Account he gives Madrass some little Indulgence, but however we never endeavor'd to deprive You of y<sup>e</sup>. like, therefore we Must think y<sup>e</sup>. design of this Paragraph was only to give some Pretence for treating Us ill on yo<sup>r</sup>. Side.

The Middlesex Cap<sup>t</sup>. Pelley who arrived here the 19<sup>o</sup>. Ultimo & proceeded for Your Port the 23<sup>d</sup>. will before this can reach You have delivered Your Honour &c<sup>a</sup>. the Packet from Europe f[or your] Presidency. Wherein You will have rec<sup>d</sup>. advice of the large Quantity of Tonnage sent us out this Year. Of the Eight Ships for this Coast & Bay Six have arrived here, the Essex and Derby are still expected. The Middlesex made no longer stay here than was absolutely necessary to fill Water. We have acquainted Cap<sup>t</sup>. Pelley that he must proceed without Loss of time agreeable to your Desire. The Sarum who arrived two Days ago & the Dawson will follow this Ship with all Expedition.

Inclosed Your Hon<sup>r</sup>. &c<sup>a</sup>. will receive Invoyses & Bills of Lading for Salt Petre Redwood & Treasure consigned to You by the Ship Mary. We should, as you desired, not have put much Petre aboard the ships consign'd us but as none of them this Year has brought out Iron Kintlage as they did the last we have an Opportunity of getting rid of a good Quantity of that Commodity by supplying them with their Charterparty Kintlage Which we are likewise obliged to do otherwise they must take in Sand before they can deliver the heavy Goods consigned to the Port, and considering the Number of Ships that will come to You this Year more than the last. We cannot doubt but they will require at least as large a Quantity of Petre as the Shipping of last Year did so that we cannot apprehend it will be any way prejudicial to our Hon<sup>ble</sup>. Masters Interest, in the present Case, that we give the Ships consigned to Us their Charterparty Kintlage in Salt Petre.

We send You Twenty Chests of Silver Coynd into Rupees & Twenty Chests in Dollars, the whole out of the Treasure sent us out this Year. We continue Coyning Rupees for You and shall dispatch the ship with them as fast as they are ready. We shall observe the directions Your Honour &c<sup>a</sup>. have given us relating to Treasure consigned to You and shall send You most part of what our Hon<sup>ble</sup>. Masters have consigned us in order to enable you to enlarge Your Investment all You can. We are in no want of Money here but have reason to apprehend a Deficiency even in the small Number of Bales we have Contracted Which We hope may be Supplied by Your Honour &c<sup>a</sup>. being so ple[n]ty and early furnished with Treasure as You are.

As Your honour &c<sup>a</sup>. find it [well that the] Bales of Vizagapatam Cloth proposed to be Washed by Your [people] should be sent early and the season being considerably advanced we may delay making that Experiment till next Year.

Having been obliged by the Misconduct of M<sup>r</sup>. Wa[ish] Deputy Governor of Fort Marlborough to dismiss him the service we have sent over M<sup>r</sup>. Torriano Supra-visor and Ordered him to en[quire] into the Demand made from Bengal on the Estate of Giles Firman and to recover the Money & report to us his Proceedings in that Affair.

We propose if Possible to dispatch the Essex (being the smallest ship) with a Thousand Bales for Europe in October In wh[ich] we cannot expect to have ready above Two thousand Bales for the January shipping. We would hope to have that Number but d[o] not depend upon it, so difficult it is with us to procure a Quantity of Cloth & Good.

At the Arrival of the Grantham from Fort Marlborô we received a Gen<sup>ll</sup>. Letter from the late Deputy Governor M<sup>r</sup>. Walsh & Council, which not giving us so satisfactory an account of affairs we Expected, nor giving any good reasons for disobeying some positive Orders of Ours, hath, with the addition of some private Advices of Mismanagement induced us to resolve to Dismiss the said M<sup>r</sup>. Walsh from his Employ, And accordingly we now send Mr. Torriano over Supravisor Deputy Governor with a Commission from us empowering him to take upon him that Post And we do require You who are nominated in the said Commission for a Council with him, to be as Assistant as lies in your Powers in giving him the greatest insight into Our Hon<sup>ble</sup>. Masters affairs as possible. We now come to answer Your Letters by the Grantham Under the usual heads.

FIRST AS TO SHIPPING.

It is a very unaccountable that You should have detained the George Brigantine Notwithstanding our repeated positive Orders to the Contrary, and the excuse is very trifling about the wants of Lascars, for if Coffrees do up and down the Coast they would likewise have done at Sea, and as for any service for her up the Coast the Grantham might have taken in all the Pepper at Moco Moco as well as she without any Expence to the Company.

It is likewise very surprising that You should send the Grantham an Empty ship to Fort St. George to be returned You when you must know, that it will be a difference of three or four Months Demorage.

SECONDLY AS TO GOODS FROM EUROPE OR FORT ST. GEORGE.

What we have sent you agreeable to your demands the Invoices will tell you, and we Expect that the utmost Care be taken of them what Medicines we can spare, You will receive by this Ship.

THIRDLY AS TO INVESTMENTS & FOURTHLY THE COUNTRY GOVERNMENT.

The Arrack & Sugar you sent us proves not so satisfactory as we hope the next will, and we do hereby give positive D[irection to] the Supravisor & the rest of You to Examine thoroughly into the [reason] he has not made larger quantities. We will not permit the advance [of] any Mony for making another Grinding House.

We are sorry for the Revolt in Anack Soongey & hope this ship will find every thing in Peace again, if not you must take [the] best Measures procureing one, as to the Dattue Buggesse we will have him encouraged for his fidelity & bravery by being entertained in [his] full Pay as formerly.

We are pleased to find you have a likelihood of being Supply'd with Inhabitants from the ill treatment the Country about you met with from Sultan Annoom & depend upon your Care & Vigilance for increasing the Pepper Trade since you know the Company's design in keeping the West Coast is to be well supply'd with that Comodity, to this end you must take frequent surveys, & be sure to keep the People to their Duty.

Your Account of the Pepper Gardens is satisfactory enough and we are willing to beleive they are true, as to the affair of Samanca & Pulo Pesong You may endeavor to get what Pepper you can from thence as well as from Lenow & Se Coonce but be cautious not to give the Dutch any handle to Quarrell.

FIFTHLY FORTIFICATIONS BUILDINGS REPAIRS & REVENUES.

We are glad to hear that your Buildings are finished [and] are done so as to last that the abominable lavishing the Company's [money] in Materials may Cease.

SIXTHLY TOUCHING FACTORS WRITERS OFFICERS & THEIR ACCOUNTS.

We observe the death of M<sup>r</sup>. Sherven & the dismistion M<sup>r</sup>. Wilford for his Notorious behavior.

We do not think proper to allow M<sup>r</sup>. Deane any In[terest] for his Bill nor for the Cooly Cogas, nor can we so well understand how [you] come to allow him so much time for making up his Accounts nor do [we] at all like your readmitting anybody after suspension before our pleasure was known as in the Case of Liev<sup>t</sup>: Jeddere, as for M<sup>r</sup>. Maskeline we can [by] no means admitt of him as a Factor but if he is inclinable to Continue Ensigne we permit it

The Complaints of Goods being stolen are so frequent from the West Coast that we can't think of allowing these Excuses, however we would have the Supravisor Examine into the affair more fully for our further Notice.

We have considered what you write about M<sup>r</sup>. Elliot & have thought fit to allow him the salary of M<sup>r</sup>. Moore from the time of his death to the receipt hereof as a gratuity for his Care & Diligence.

We can't tell how to admit of any increase of the Expence on the Coast however if it be found absolutely necessary we must permit you to Entertain a few more Ruggueeses, for we cant supply you with Soldiers being ourselves very much streighten'd.

We send you Ten Lascars & a Syrang for the George Brigantine & have advanced them Four Months Imprest.

We likewise send you some Longcloth for Purchase of Pepper at Moco Moco & do order that in future it be paid away to the Malays and no more than 75 Dollars & ₤ Corge & if any one whatsoever shall pay it away at a greater price he shall immediately be turned out of the Service.

You must give us Credit for one hundred Pagodas for the Supravisors Passage over.

Inclosed You will receive Invoice & Bills of Lading for Wares and Stores Consigned You as also separate Bill of Lading for Petre furnish'd Cap<sup>t</sup>. Feild at his Request which you must take Care to include in a separte Bill of Lading to England. We wish this ship safe to You & are

SIR

We herewith deliver you a Commission appointing You Supravisor & Deputy Governor of the West Coast of Sumatra in which station We hope you will behave yourself so as the extraordinary Trust reposed in You requires and so as to answer our Hon<sup>ble</sup>: Masters expectations on these ocasions.

The way to do this is to be exact in Your examination of the Companys affairs at Bancoolen to beleive nothing too minute for your inspection, but to search strictly into every particular. To be carefull to find out what is the reason we have been disappointed in the Pepper and [how what] has been Received was paid for, You are also to examine why [he] has been advanced so much Money, and why he has me[ . . . ] Arrack & Sugar. What has been done with the Companys Treasure which we have hear'd has been part of it unjustly made use of by the late Deputy Gover<sup>r</sup>. You are also to enquire how and in what manner the Companys

Wares & Stores have been disposed of or employ'd, whether there be any or what mismanagem<sup>t</sup>. in the Military and buggeeses and in fine You are to examine every article in the Company's Accounts and give us full and clear reports [ . . . ].

You carry with you some Letters of At [ . . . ] Creditors of M<sup>r</sup>. Walsh which we permit you to execute [& when] you [Compare] the Companys Accounts with M<sup>r</sup>. Walshes & those of the said Creditors and [all the] Legal Demands are comply'd with by him You may permit him to go to Europe on the Grantham or else to come hither, by the first Conveyance that offers. You must also remember to examine into the Accounts of Cap<sup>t</sup>. Giles Firmins Estate & remit the produce to us, we having rec<sup>d</sup>. Letters from the Bay requesting we would give such Orders.

We give You herewith Copy of the Hon<sup>ble</sup>: Court of Directors Instructions to our President when Supravisor of Bencoolen & of his report of his Transactions on his Arrival here which you must be carefull to see have been comply'd with since his departure, Your carrying them with you makes us the shorter in these Instructions.

You must dispatch the Grantham to Europe with all speed and if on the Carnarvons arrival You have Pepper enough with the September Crop to load her within Forty Tons you are to do it & send her home because the large quantity of Tonnage & the difficulties of providing Goods will make it impossible for us to dispatch her before August 1727. [And] therefore it will be much more for our Masters advantage to pay de[morage] Freight for so many Tons than demorage till that time.

In Case you have a prospect of thus Dispatching Carnarvon You may keep the George Brigantine to bring you back, [otherwise] You must send her away immediately after you are able to give an [ . . . ] on Your examination You should find M<sup>r</sup>. Carnegie clear of the [ . . . ] complained of in M<sup>r</sup>. Walsh You may leave the Government [with him but if] he be faulty orderd you must then continue at Bencoolen till [further] orders from us, an the same should M<sup>r</sup>. Carnegie be in an ill state of health [as he] may probably be incapacitated from taking that Charge on him.

We have received this Year the following Paragraph relating to M<sup>r</sup>. Hubbard.

We observe the Letters by the Sunderland endeavors to extenuate M<sup>r</sup>. Hubbards management and to blanch over his Actions while Supravisor of the West Coast. But we say there is no contesting with plain matter of Fact, the Expences in his time were prodigious. Let him if he can show us [what] Valuable retrenchments he made, did he not rather give a sanction to the lavish expences of the Coast by shifting only the hands but not lessening the disbursements If his Ten thousand Dollars Bill You paid was payable in a great part to Cap<sup>t</sup>. Pyke why was it to be kept in the dark, would not plain truth best justify itself. In a word whatever any of you may think or would suggest to Us we cannot at all commend his management, nor think the better of those that endeavor [to] justify it, and thô Cap<sup>t</sup>. Pyke is mentioned as unworthy to be believed and the very naming him makes the subject disagreeable to the Penman, It is very plain that some things he told us carry'd the greatest probability of Veracity, and that the Council of Fort St. George thought their orders superior even to ours, with relation to his being Deputy Governour, Let this Account of M<sup>r</sup>. Hubbards be again examin'd by the New Council, and send us how You find it. Our now President being a good Judge whether he is or how further Culpable.

We therefore direct that you do make it your business to Examine into and make Your self Master of the Accounts during His Supervisorship, and give us the fullest Acc<sup>t</sup>. thereof that you are able, that so when you shall have made the Report we may the better proceed to the putting Our Hon<sup>ble</sup>: Masters Orders in execution.

You must further examine into the Moco Moco Accounts and know why they are not passed as they ought to be.



We are in hopes the September Crop will be sufficient for the Carnarvon, but should it not, keep her with you for the Febry Crop, wh[ic]h we expect will be enough, but should both fall short, You are then to send [her] over here in May. We are

The Owners are much obliged to You for recovering the Sume of Rupees You have from the Rajah. We recommend it to You to use Your Endeavours for Recovering & Securing all you can of the Wreck and Cargo. That Brigantine was freighted from Gombroon for Bengall by Cap<sup>t</sup>: Dixon of Calcutta, To whom it will be proper you give the earliest Intiligence You can of this Misfortune as we shall to [ . . . ].

[We] observe Your having paid Pagodas 4. 32, — for dieting Your Soldiers upon their Passage. That You will make the Beaters repay the Money advan[c<sup>d</sup> on] account their Wages, and that You are resolved to take Care th[at what] You cure shall not be over Conjeed. We would have you co[m]municate] to Mr. Blunt what we writ You on that Subject, for which reason, the Clothe lately received from him being too much [conjeed we m]ust likewise observe to you that thô he promised You to have [bales ready] to be sent upon the Speedwell by the 20 August & writ [ . . . ] that he had then 100 & expected 60 more against that, [The speedwell] Arrived us a few days ago with but only 118. By the Brigantine [Fortune arrived] here the 4<sup>th</sup>. inst<sup>t</sup>. we received Your Letter of the [29<sup>th</sup> August] by Duplicate of a Preceeding, which is [ . . . ] we reckon sent by the French ship, [expected daily at] Pondicherry, We have likewise received Duplicates [of your] Letter of the above mentioned date by Sloop Elizabeth [ . . . ] arrived next day, But thô your Duplicate rec<sup>d</sup>. as above [says that] You had Inclosed the Account Curr<sup>t</sup>. of your Presidency with this; for last Year, with answer to the List of Errors in the Europe Invoices & Invoice of Stores sent upon the Enfield, we found neither of said Papers inclosed. In answer to the Duplicate Your Honour & c<sup>a</sup>. will find in our Letter by the Darby, that thô we did not then [ . . . ] the Quantity of Salt Petre we had in Warehouse, yet we advise[d] that we should want nothing from Your Presidency this Year [but fifty] Jarrs of Oyle which we hope will be sufficient to determine [&] to alter Your Resolution for sending us a Quantity, as you [can as] of Salt Petre upon the Returning Ships: [If] had we been in want or had but a small Quantity of that or any other Stores or Wares on [ . . . ] we should not have faild to advice [Your Hon<sup>r</sup>. & c<sup>a</sup>.] of it as we have done of the Oyle we wanted. Should [ . . . ] as you propose, we would be obliged to return [ . . . ] ships, For we have now in Warehouse 5000 Bags and upwards, which will be sufficient for all Demands here for several Years, Especially as we have no prospect of Dispatching an October Europe Ship next year, nor can we expect the outward bound Europe ships should be prohibited bringing out Iron Kintlage next Year as they were this, and even thô they should and should we be able next year to Dispatch an Early ship, we shall be able to supply them. Admit even that the next Years Europe ships should come out without Iron Kintlage & we not have Petre enough to Kintlage them with, We can see no reason why Your Hon<sup>r</sup>. & c<sup>a</sup>. should send us Petre to Kintlage y<sup>m</sup>. with here, because by so doing you would expose that part of the Hon<sup>ble</sup>. Company's Estate to a Double unnecessary Risque, first from Your Port to this and than back again to You, Besides putting them to ad[ditional] unnecessary Charge in Landing said Petre here in reshipping back to you. The argument that unless we have sufficient on [hand] to Kintlage Europe Ships here they may be obliged to take on [ . . . ] hand after having delivered their heavy Goods, in order to [ . . . ] they can proceed to You, would not in our Opinion [ . . . ] & Charge we have mentioned: Because should so [ . . . ] Suffering they must take in Land at their own Charge, do without any Loss of time But Your Hon<sup>r</sup>. & c<sup>a</sup>. add th[at the] Masters have Ordered in their this Years General Letter [ . . . ] send us up a sufficient Quantity of Salt Petre To which [ . . . ] that we have already more than sufficient on hand & [send us] a supply when wanted.

It is very agreeable to us to be in [formed by your] Hon<sup>r</sup>. & c<sup>a</sup>. that notwithstanding the Scarcity & high Prices [of cotton] yet You have good hopes of being able to provide for the [ships on h]and, with the Assistance of 3000 Bales from us We are [not sure of] that Number, but cannot depend upon above 2500 or [ . . . ] as formerly advised to you.

We have according to promise sen[t your] Hon<sup>r</sup>. & c<sup>a</sup>. all the Treasure we could this year, & with all the Expedition possible amounting to in Rupees Ninety Chests, each chest [containing] 8000, Ic Rupees 744,000 and in Bullion 47 Chests exclusive upon the Craggs Orderd for Bombay. We should be very glad to hear of Your Success in rendering the Projects of the Ostenders ineffectual. The service is of great Importance and would be regarded as such.

We are obliged to Your Hon<sup>r</sup>. &<sup>cs</sup>. for the Assurance You give Us of dispatching one ship as early as You [can] with Orders to call at Vizagapatam & bring us up their [clothes] in time to be Cured [here].

There is at present nothing of Cap<sup>t</sup>. Alan[a . . . ] to be found here. Mess<sup>rs</sup>. Llyod & Braddy[m]ay be assur'd that we will be very ready to give our assistance to their Attorney in any affair of theirs upon Application made to us.

Two ships were dispatch'd the 30<sup>o</sup>. Ult<sup>o</sup>. from Pondicherry for Europe upon one of which the late Governour Mons<sup>r</sup>. [ . . . ] Bearevollier took his Passage a Third waited till y<sup>e</sup>. 7<sup>th</sup>. inst. for [an . . . ] from the Ganges, W[h]o not being then arrived the other was dispat[ched] with Your Letter for the Hon<sup>ble</sup>. Court of Directors being [forwarded] to Mr. Pitt it reached just time to enough to [ . . . ]

By the George Brigantine [ . . . ] to us the 13<sup>o</sup>. of August we received a General Letter [from the] then Deputy Governour & Council under date the 21<sup>st</sup>. June [to] which we now write in Answer under the usual heads.

#### FIRST. AS TO SHIPPING

We shall not now repeat the reasons we had to be dissatisfy'd with the then ill Conduct in detaining the Grantham so long unnecessarily & sending him to us at last empty but refer You to the reperusal of the Accompanying Duplicate of our Gen<sup>l</sup>. Letter by the Grantham & of our Instructions to the Supravisor recommending it to you with peticular Earnestness that You Joynly use all your Endeavours to prevent

upon all occasions [the] Charge of Demorage to the Hon<sup>ble</sup>. Company Which affects their Estate so very sensibly when ships are so long Detained as the Grantham has been.

The care taken to write to the Hon<sup>ble</sup>. Court of Directors Via Batavia by the Conveyance that then offer'd, the state of [ . . . ] that time & to accompany the Letter with abstract [of . . . ] to be commended & we hope will be imitated.

The reason assigned for not returning George Brigantine to this Coast in the Month of April too early in the Season, could never pass with us & ought [to have] been offer'd by Persons that know as well as we that the [ship] has been dispatch'd for this Port much earlier, and every [one that] understand y<sup>e</sup>. Navigation between Madrass & Fort Marlbrô knows] that the Month of April is a fit season for shipping to [ . . . ] from thence hither, The other pretence of bringing up Pepper N<sup>o</sup>.ward deserves equal Censure, For the Authors of it know [that the] Companys ships are obliged to perform that service & that [ . . . ] field when on the Coast was so employ'd, What by unnecessary [ . . . ] as unnecessary Delays that Vessell return'd to us little than a Wreck and in want of every thing In so much that [we have] been obliged to send her to Pegue to be Repaired & refitted [ . . . ] her Charge upon the Coast will be a very considerable addition [to the] Expence of that Settlement. We have already express'd [ . . . ] Resentment against the Principall Authors of that and many Evills Which we now recommend as an usefull Caution to him.

We observe Your advising the Arrival & Departure of shipping from Your Port Which is according [ . . . ] and very proper to be known, We direct that you do continue [ . . . ] and with exactness & that you be very vigilant in preven[ting . . . ] of the Order against Landing unlicenced Goods [ . . . ] may happen to call at Your Port occasionally such Case the Company will lose their Customs, such Goods [ . . . ] only to be landed in a Clandestine manner, For if offer'd to [an . . . ] You cannot allow it, & if you thrô neglect or otherwise suffer them [ . . . ] I'un, Tho the Purchasers may save the Duty yet you are unfaithfull to your Trusts We recommend that Branch of the Revenue to be improved and hope it will as much in future as it seems to have been neglected lately.

We expect to see Articles of Customs paid upon considerable Quantities of Salt &c<sup>a</sup>. imported & now [ . . . ] have mention'd Salt we shall likewise expect to find that what may be laded upon the Company's Vessells for Mocho Mocho &c<sup>a</sup>. when it shall be found necessary for the Service to send any of them to y<sup>e</sup>. N<sup>o</sup>.ward shall have paid them Freight.

This goes by the ship Marlbrô Cap<sup>t</sup>. William Montgomery, if Mr. Tempest should not have found a Passage [to] You from Batavia, You must dispatch the Marlbrô immediately upon her Arrival to bring him. By the time she can [ . . . ] which you must so Order Cap. Montgomery to do with all the Expedition he can, we Judge M<sup>r</sup>. Torriano will have finished Business we sent him upon & direct that he may take his Passage upon her back to us without the loss of time, We have purchased [that] ship for the Companys Account principally to attend the Service of the West Coast & recommend it to you to manage her Expence while with you with all the frugality you can.

We have nothing to add in [ . . . ] Dispatching the Carnarvan to what we directed in [ . . . ] to the Supravisor Exert Your selves all you possibly can [ . . . ] him Directly to England Which as it would be very much [ . . . ] rest of Our Hon<sup>ble</sup>. Masters by serving them [ . . . ] would be very acceptable to us & recommend Your Service.

SECONDLY. AS TO GOODS FROM EUROPE, FORT ST. GEORGE.

You will have found Your Lists by the Grantham comply'd with as far as we then could & the Ninety three Fire Arms Demanded instead of the like Number worn received by said ship are now sent You by this together with 4 Drums, Drum heads 8 D<sup>o</sup>. slings 2 Braces 4 Hinges Ninety, Brass Ware 6 'and Iron Stone 44½ Tons in number 1232 as 4 Invoice & Bill of Lading inclosed Which will be very usefull w<sup>th</sup>. You.

What Goods have been licenced to [be sent] to Your Port upon this ship you will find comprehended in the Accompanying Manifest.

### THIRDLY: CONCERNING INVESTMENTS.

#### FOURTHLY: CONCERNING TRANSACTION WITH THE Co[UNTRY GOV<sup>r</sup>.]

You tell us You had then a Warehouse there and at Sillebar 716 Bahar of Pepper Which we must believe upon your telling us so in Your Letter. It cannot be confirm'd to us from Your Pepper Godown Keepers Account because you have lately introduced a Method of keeping these Accompts in hund<sup>ds</sup>. only. Whereas formerly the Number of Bahars was always exprest in the Mocho Mocho Accounts' till December last. We can assigne no good reason for this New method & do direct that the Number of Bahars paid for may be exprest as formerly, We know y<sup>e</sup>. Company pays for it in Bahars which ought to be Net W<sup>t</sup>. to them, because the Mallays always allow sufficient upon each Draught to make the Bahar weight Effectual. We de[sire] a calculation first Opportunity of a exact weight of a Mocho Mocho Bahar & a Fort Marlbrô D<sup>o</sup>. and what quantity of Pepper goes to make a Ton in shipping it.

We should be very glad to hear [about the dispa]tch of the Grantham, You had found Pepper [for] the Carnarvan, his Tonnage likewise within the time This would give us Encouragement to Depend upon [ . . . ] the West Coast & Retrieve the Reputation it has by [ . . . ] forfeited. We must say Ill management for by Accounts [ . . . ] lately in Trust the Quantity of Pepper produced ought to be very considerably increas'd. Which we expect will [ . . . ] to us by your giving the next Europe ship an early Dispatch having on hand a good Quantity more, So as to encourage [ . . . ] You two Ships Yearly.

We observe your Reasons why see [ . . . ] not hither to make a larger Quantity of Sugar and Arrack [We] are afraid upon Enquiry which we Direct the Supravisors [ . . . ] to make will not be found the same they are represented [ . . . ] all the Money advanced him been in Dollars he must [ . . . ] more forward by this time or very remiss in his Business [ . . . ] Cloth will never bring Necessary People & Utensils from [ . . . ] The Spanish Dollars would very readily there's no roome doubt.

We have tried all we could but can[not] prevail with any Potters to go from hence & the Earth the [Potts are] made of here is so mixed with Sand that they would never [be of] use for a Sugar work, You must procure a Workman from Java [ . . . ] own fine Clay with the assistance of Slaves under his Direction [ . . . ] ver the Purpose much better.

You must inform Yourselves from S<sup>t</sup>. Helena by first opportunity what Quantity of Your Sugar & Arrack [will] be wanted there and supply them accordingly. What Arrack and Sugar are necessary for Your Settlements you may dispose of for most they will bring, What Sugar you shall have remaining will find a Market here, Until we have Directions from Our Hon<sup>ble</sup>. Masters we cannot say precisely what Quantity of Arrack You are to sell them, But you may send them a proper Quantity by every occasion out of what you shall have on hand & the rest [ . . . ] after you are supply'd Yourselfes.

It is very agreeable to us to be inform'd that the Country continues in Peace, which You must Cultivate & entertain with all the Art & management You can, As the Copy of the Presidents Instructions when Supravisor of the West Coast is with You, Which are full of the best directions possible to be given for your conduct towards the Mallays of all Degrees & for Manageing [the] Company's Interest to the greatest advantage, we refer you [ . . . ] for what further may be said under this [we would] recommen[d] You to reperuse them frequently & faithfully to observe them.

### FIFTHLY: TOUCHING BUILDINGS, FORTIFICATIONS & REVENUES.

Mr. Carnagie having acquainted the President by a Private letter that the Companys Slaves are capable of making Bricks & Chinam we order that they may be so Employ'd & [there] after there shall be a proper Quantity of those Materials [...]



if it should be found absolutely necessary to rebu[il]d those . . . ] Godowns or other buildings you do rebuild them with [ . . . ] some of the slaves are pretty expert Bricklayers they [ . . . ] on that Work & others as Cooleys. We cannot neither prevail [with] any People here that understand Tarrasing to go over to You, You must therefore do the best you can with the hands You have [who] we hope with proper Directions may do well enough, let such buildings be very durable & strong enough to resist the small shock of Earthquakes with You. You must prepare the Wooden Materials in time & take care they be of the most durable sort & duely season'd and in all things to Study the Interest of Your Hon<sup>ble</sup>: Employers by being frugal of their Money & building strong & only what's Necessary.

The Letter we now answer only [ . . . ] that having no other service for the slaves they were then [ . . . ] in levelling the Roads leading to the Fort. But we find in Consultation of date the 16<sup>th</sup> March, That the Deputy Governour was about enlarging his Lodgings from the Fort to China Row &c<sup>a</sup>. By the Acc<sup>t</sup>: given in said Consultation [ . . . ] intended building we cannot tell what to Judge of it, [ . . . ] Work we apprehend is Could he propose or [you agree] to [his] build<sup>g</sup>: anything Contiguous to the Fort or give him & [ . . . ] Right as there mentioned to any Ground joyning to it, It is there said he was to build upon the Cartain, We cannot tell what to make of it or how to understand it as there express'd But we forbid proceeding with it till the Ground is more particularly described to us, and our Leave obtained for carrying it on, We hope we shall not hear that the Companys Slaves instead of levelling Roads were employd in levelling the Ground for his building and carrying on the Edifice.

We can give no attention to such Petition as that mentioned of the Farmer of the Arrack & Opium Licence which You your Selves had rejected & then by way of after Tho[ught] recommend to us without one Reason<sup>offer'd</sup> for so doing, such [a] Recommendation deserves a higher Censure then we shall [wish to] put upon it.

If the Arrack & Opium Licences could [produce] no more than Three Hundred & thirty Dollars we [must be satisfied]. But as Your Numbers will quickly if [not very] considerably increased, we shall expect an Im[provement].

#### SIXTHLY: TOUCHING COVENANT SERVANTS, OFFICERS, SOLDIERS & THEIR ACCOUNTS.

We were heartily concern'd to [hear of] of such a Diminution of Your Number by Mortality [ . . . ] Mr. Fotheringham will have behaved well untill the [ . . . ] of servants arrives you, when you will be well pr[o]vided with a Resident for Mocho Mocho. We have appointed [Mr.] Lenox to that station wherein we hope he will give [satisfaction] Being a Man of Good Sense Knowledge & Experience in [Mercan]tile affairs & desire thô he is third of Council you may [send him] to his station as soon as conveniently you can. Mr. J[ulius] Gollop Fifth of Council we have appointed Your Pay[master] believing him to be a Man of Probity & Capacity for that [Employ] We send You likewise Mr. Jos<sup>h</sup>. Goddard Factor a sober Young man of some Experience in Business. You will station him as you [may] Judge most usefull. We have advanced Mess<sup>rs</sup>: Lenox & Gollop [Pag<sup>a</sup>.] Thirty each & Mr. Goddard Pag<sup>a</sup>. Twenty for the Charge of the Passage, for which You must give us Credit

We observe the Paragraph relating to Mr. Welshes Conduct towards the then Deputy Governour & Mr. Can<sup>negie</sup> and would have him know that in consideration of his Experie[nce] in affairs there which may render him usefull if he behaves well we [shall] not Pass upon him the Censure he deserves for his [unbecoming] & irregular Behaviour towards those Gentlemen [& that] it will be prudent in him to avoid giving the like occasion [for] complaint in time to come. For thô we permit the Dissenting to any thing that is evidently contrary to Orders & Rules yet we will not permit such irregular proceedings nor such an unbeco[m]ing Behaviour as those Complain'd of in Mr. Welsh.

Upon this ship we send You Ten Europe Soldiers Which is all we could spare, they have received each three Months Pay advance ending Ultimo December, and Bradley's Wife who now goes to her husband has received three Pagodas on his account You will Pay Cap<sup>t</sup>. Montgomery the Usual Diet Money for the Soldiers upon their Passage.



You may transmit us the Accompts of Daniel Eden Cavellry's Effects & we shall Pay the Amount here to those who shall make a legall Demand.

We come now to tell you that having good Experience of Mr. Carnegie's Integrity, Capacity & Application in the Hon<sup>ble</sup>: Company's Affairs we have Unanimously appoint (*sic*) him Deputy Governour of Fort Marlborough [we] send you Inclosed a Commission to that effect & appointing Mess<sup>rs</sup>. Geo: Tempest Second Rob<sup>t</sup>. Lenox third David Welsh fourth Julius Gollop fifth & John Savage sixth of Council. After this Instance of our confidence in Mr. Carnegie we shall expect from him due Returns of application in the Companys Affairs & a hearty and steady zeal to promote their Interest that we receive no longer trifling & evasive answers to our Letters and that we be n[ot kept] in the Dark as to the state of Affairs by receiving only im[perfect] or fictitious Accounts from thence. We require all of Co[uncil] to concur with him heartily in the Service particular[ly in] improving the Pepper Trade & enlarging it as much as [possible] Which & a frugal management of the Company's Money [must] be always their Principall Point of View.

The abovementioned Commission is not to take place till Mr. Torriano coming away in as far as it relates to Mr. Carnegies being appointed Deputy Governour until which time after the Arrival of the Gentlemen now sent of Council Mr. Tempest is likewise with You the Council will be full, so that Mr. Savage will only take his Place at the Board then. We hope he will continue to deserve & increase the good opinion [we have] of him, in his new station, which will entitle him to a further Promotion as occasion shall offer.

Mr. Torriano will have finish'd all matters recommended to him as our Suprvisor by that time this ship can be dispatch'd back to Us, which we desire may be as soon as you can & then will take his [passage upon that ship].

Having received a very good Character of Lewis Perry who has served some time with You under the Paymaster & given good Proof of his Capacity & Application, we have entertain'd him a Writer in the Company's Service to take his standing from the Arrival of this ship with you.

#### SEVENTHLY: TOUCHING ACCOMPTS.

We received in last Packet the two Copies mention'd of Consultations Monthly Accounts & Letters Received & Sent One Copy of which we shall transmit to England in our first Packet with Your General Letter to the Court of Directors. You must continue to be exact in sending Your General Books, Consultations &c<sup>a</sup>. and always a Copy to us to be forwarded home.
