Instant We dispatch'd the Dawson with One hundred sixty six Bales, and this comes by the George with One hundred Seventy one being all We could possibly get ; a[nd] We are very sorry it was not in our Power [to send] more but the Country both to the Southward, and North [ward]h [as been so disturbed] by the Rajahs, and other [great] Men endeavouring to depose one Another that the Inhabitants were kept in continual Fear of being plunder'd, and the Weavers could not with any safety carry on their Business as usual [ . . . ] wish for an Alteration, though at present We [have] but a very bad Prospect of it.

According to the Liberty grant[ed] by yo<sup>r</sup>. Hon<sup>r</sup>. & c<sup>a</sup>, to M<sup>r</sup>. Davis he now takes his Passage on this Ship, and We send our Diarys Consultations Cash, and Paymasters acc<sup>ts</sup>. for last Year with three last Months of October, Nov : & Dec<sup>r</sup>. separate. Inclosed is Invoice and Bill of Lading for [ . . . ] hundred Seventy one Bales, amounting to Ten [thou]sand three hundred, and Eleven Pag<sup>s</sup>. [ . . . ].

HON'BLE SIR & SRS,

We are favour'd with [your] Letter of the 25<sup>th</sup>. Instant Directing us to [send] Sloop Rama with the Waste & Damage [of the] Stores by her last Trip, which shall be [duly] obey'd. We have also your Inclosd In[voice] of her last Cargo, Which though arrivd is [not] ashore yet.

We shall duely Transmitt [the] account of the French Cargoes as soon [as we] receive it.

We sent one of our Gunroom Mates to take charge of the Conveyance of the Porto Novo Cloth above a week ago, and hope [it] is now well arrivd.

Your Hon<sup>r</sup>. & C<sup>a</sup>. will observe [here] under what Cloth is yet come in, And the merchants being reminded of the short[time] they have left for Discharging their Engagements, Sha Permall & Tomby Chitty's Mer[chants] ask'd one thousand 1000 Pagodas each, in payment for Cloth brought in, which, [to] enable their better Dispatch, we according[ly] paid them.

These Tappies have one set of [our] last Year's Books, The other shall wait on [you] with our Europe Packet.

Inclosd is our [...] account, The Paymaster's and other [...] here, beginning as directed, in the month September shall follow as soon as those acc<sup>ts</sup>. are pass'd.

HONOURABLE SIR & SIRs

1. We shall herein Acquaint Your Honour & C<sup>a</sup>. of what material hath occur'd on this Coast since our last General Letter 4<sup>th</sup>. Ship George, dated January the 2<sup>d</sup>. 1731/2 as also reply to that which we have now receiv'd by the Madrass Galley, Captain Robert Cannaway Commander all which [we] propose to do under the following [heads] Viz<sup>t</sup>.

FIRST CONCERNING SHIPPING.

2. There has been no Ship or any other Vessel from any foreign port at an anchor in Bencoolen Road, since the dispatch of the Ship George from hence for Madrass, till the 12<sup>th</sup>. July last when the ship Enfield, Captain Thomas Manley Commander,

anchor'd in our road from Great Britain but last from Battavia the reason of her touching there, we have demanded [of the] Captain in writing pursuant to [order] which he hath given us according[ly] and we have inclos'd a copy thereof in our Packet for Your Honour &c<sup>as</sup>. [perusal].

3. The Ship Enfield we find by Charterparty, is let out to the Hon<sup>ble</sup>. Company for 460 Tons, which is a great Ship for this Coast, but it being indeed what we expected, beg leave to assure Your Honour &c<sup>a</sup>. that our care and Vigilance in order to her dispatch hath been great also even thro' the whole Extent of the Companys Dominion, and our endeavours having been crown'd with success, we [think] we may venture to assure Your Honour &c<sup>a</sup>. that the Enfield will be dispatch'd from Fort Marlborough with her Charter Party Tonnage, & that without [a] farthing charge of Demorage to our Hon<sup>ble</sup>. Masters.

4. We intend to put on board the Enfield here before she goes to Moco Moco, about 150 Tons of Pepper, which we are now busy in performing and hope shall dispatch her to the Northward in a very few days.

5. We perceive the Madrass Galley was dispatch'd from thence the 28<sup>th</sup>. of February last, but did not arrive here till the 21<sup>st</sup>. of July. being almost five months and the ship George was as tedious in her passage last Year. Your Honour &c<sup>a</sup>. [expected] her back at Madrass in the [month] of September from hence, and she did not arrive here, till the latter end of October; These long & tedious Trips that have happen'd of late Years between Madrass & Bencoolen, hath without doubt been a great disappointment to Your Honour &c<sup>a</sup>. in Your expectations, and hath been & now is, both a very great disappointment and Loss too, to us here to be visited but once in a Year by a small vessel of eighty or a hundred Tons, we humbly beg leave to represent to Your Honour &c<sup>a</sup>. is not sufficient for the necessitys of this Coast. We have not a piece of white Long Cloth left to purchase Pepper within Anaksoongy, at which the Merchants there are much dissatisfied, but we have prevail'd with them to deliver the Pepper this season, upon a promise that they shall have Cloth as soon as it arrives. We therefore pray Y<sup>r</sup>. Honour &c<sup>a</sup>. will supply us with what we indented for by the George, as soon as the same can be conveniently done.

6. Your Hon<sup>r</sup>. &c<sup>a</sup>. will please to observe by the date of this Letter, that we deliver'd the Madrass Galley of her Cargo consign'd to this place, and dispatch'd her with our Packet back again to Your Honour &c<sup>a</sup>. in 24 days, and we assure you the like Industry was us'd in unlading the Ship George, and should have dispatch'd her [in] near the same time, had it not been owing to her own Misfortunes, in having a very foul Bottom, bad rigging, and worse Cables, which was the sole Cause of her long detention at this Port and if the like detention should happen to any future Ship, consign'd to us by Your Honour &c<sup>a</sup>., you may be assur'd it will proceed from the same cause; for we hope we shall always exert our selves so, in the Service of our Hon<sup>ble</sup>. Masters, as not to deserve the censure of Idle, and Sloathful Servants.

7. On the 23<sup>d</sup>. of July arriv'd in our Road and Anchor'd there, the Anna Catharina, a large Ship belonging to the Dutch East India Company & bound for Canton in China, but falling to Leeward of the Streights of Sunda, was forc'd by the South East Winds to come here, and was in great distress, having buried 25 of her Men, and most of the rest of them were very Sick and unserviceable, but we have assisted them at their request, with every thing by way of refreshment, that this Coast would afford, and they are by that means greatly recover'd, and they intend to sail for Batavia with the first fair Wind.

#### SECONDLY CONCERNING GOODS FROM EUROPE & FORT ST. GEORGE.

8. We have receiv'd by the Ship Enfield twelve Chests of Treasure, which was open'd and weigh'd off in the presence of Captain Manley, and was right according to Invoice, after which we counted over the whole Quantity of Dollars, and made the amount to be Forty eight thousand, three hundred, & twenty seven Dollars, & three <sup>Sa</sup> sucas \$18327. 3. which we have accordingly brought to Accompt. We likewise



receiv'd by the above Ship, twenty two Soldiers, out of twenty nine that were consign'd to us, M<sup>r</sup>. Pyke at S<sup>t</sup>. Helena, detain'd seven of our best Men there, which is an old Practice he used formerly to be guilty of, but we humbly apprehend such practices are unwarrantable and unjustifiable, and is at the same time using both the Hon<sup>ble</sup>: Company, and us, very ill; we therefore hope, if your Honour &c<sup>a</sup>: write to S<sup>t</sup>: Helena this season, You will be pleas'd to reprimand him for it. We also receiv'd from S<sup>t</sup>: Helena by order of the Company, thirty Slaves, that is to say, Eighteen Men, Eight Women, & four Children, most of which after we have dispatch'd the Enfield for England, we intend to employ at the Sugar Plantations where we hope they will be of good service. What else was consign'd to us from England was all right as P<sup>r</sup> Invoice, but in the list of Stores sent home by M<sup>r</sup>: Newcome in the Mountague, The article of Gunpowder was omitted, so that we being at present but very indifferently stock'd with that important Article, do hereby humbly request Your Honour &c<sup>a</sup>: will assist us with twenty Barrels of Europe & Country Powder; by the first Conveyance.

9. The Several articles mentioned in the Invoice and now consign'd to us by Your Honour &c<sup>a</sup>. in the Madras Galley, we have receiv'd there was some Wastage in the Salt, but much more in the Jaggery by its being put into Gunny baggs. If for the future that commodity be put into Pegue jarrs, all wastage by that means will be prevented.

[10] We have taken such care to encourage the importation of Salt from Java, and are now so well and Sufficiently stock'd with it, that we hope there will be no occasion for the future to trouble Your Honour &c<sup>a</sup>. concerning that Article, what Stores &c<sup>a</sup>: we are in want of that was not mention'd in our List P<sup>r</sup>: Ship George we have now sent inclos'd in our Packet, to which we referr, and pray they may be sent us by the first opportunity.

11. We were in hopes of receiving by this Galley the Plank for the frames of the two Boats brought by the George, because there is now here belonging to the Europe Ship two very good Carpenters that wou'd soon have compleated them, and they might have done the Company good service this present season, we shall however set up the frames, and hope by the next Ship shall receive the plank in order to render them Serviceable

3<sup>d</sup>LY: [THIRDLY] TOUCHING INVESTMENTS  
FOURTHLY COUNTRY GOVERNMENT.

12<sup>th</sup>: By the Advices we have lately receiv'd from Moco Moco, we have reason to expect a good increase of Pepper from that Country and we have receiv'd from Manna since our last Letter to your Honour &c<sup>a</sup>: in all, one hundred & thirty Bahar of Pepper which is a noble Addition to our Stock on hand, and we expect as much more from their present Crop which is now gathering; the last crop from Laye, gave us about One hundred & fifty Bahar, and we are in expectation that the present Crop there, which is also now gathering, will amount to near Two hundred Bahar. The Countrys of Konkoy, and Andelas, near to Sillebar, are in much better order than they have hitherto been in, with respect to their Pepper Plantations, and indeed the whole Country is at present, in a quiet, peaceable, and prosperous Condition, which we will endeavour to the utmost of our Power to maintain, and in all respects to further and promote the Hon<sup>ble</sup>: Companys Interest, by encouraging the growth and increase of Pepper, and also of Coffee if it can be done.

13<sup>th</sup>: We humbly represented to Your Honour &c<sup>a</sup>: in the General Letter by the George, our Opinion concerning the raising up of Coffee here, and therein also pray'd your consideration relating to that Affair, and your farther directions to us upon it we therefore beg leave to refer to said Letter, since which, Dupatty Battoo Rajah, whose plantations are near Laye, and in a fine Soile and to all appearance very proper for producing Coffee, hath been with the Dep<sup>y</sup>: Governour and propos'd of his own accord, to make a plantation of Ten thousand Coffee Trees, the ground for which being already clear'd, the next thing to be consider'd of was the price, and the Dep<sup>y</sup>: Governour offer'd to give him Ten Dollars P Bahar (the price of Pepper) for

the produce of the said Ten thousand Trees, or any greater number he might hereafter set, which he readily agree'd to, and was furnished accordingly out of some little Gardens in our Neighbourhood, with several thousand small Coffee Plants, & Berries fit to put in the Ground; this Agreement we hope will be thought a good one, because it is not likely to discourage the Pepper trade, & for which reason, we will be sure to give all possible encouragement to it, and to all others that we can make upon the same Terms.

14<sup>th</sup>: We also Acquainted Your Honour &c<sup>a</sup>. by the George, that Siddy Ibrahim was then upon an expedition against the people of Laboong, & that we had plac'd a party of Buggueses at Battoo Rajah, which is a pass in the way between this place, & that; to prevent all supplys of Men & Amunition being sent to him, and to hinder him also from all intercourse of News from these parts; our orders herein were well executed; and our designs very well answer'd, for he was so entirely disappointed in his expectations at Laboong, that after a stay among them upwards of two months, he was oblig'd to make a shameful retreat home again, by a private round about road without having obtain'd the least Advantage since his return he hath been very quiet, and we are well inform'd he never will undertake any more Journeys of that nature, which we hope will prove true, however we shall nevertheless keep a good lookout about his Quarters, that if he should at any time be preparing for mischief, we may have early notice of it in order to prevent his ill designs from taking Effect.

15<sup>th</sup>: The Affairs of the Sugar Plantation are at present in much the same Condition they were when the George was dispatch'd from hence, but when the supply of Slaves we now have receiv'd from S<sup>t</sup>: Helena are sent there, we hope their assistance will greatly contribute to the better and more successfully carrying on of that Work.

16<sup>th</sup>: Pangaran Megong Boomy of Manna, having been dead almost two years, we did in the month of March last make a new Pangaran in his room and last month we made another new Pangaran for the Country of Andelas, in the room of Pangaran Neore deceased our reasons for which, are enter'd in Consultation of the 31<sup>st</sup>. of March, & 20<sup>th</sup>: of July to which we refer, and hope they are such as will meet with Your Honour &c<sup>as</sup>. approbation.

#### FIFTHLY AS TO BUILDINGS FORTIFICATIONS REPAIRS & REVENUES

17<sup>th</sup>. The new Lodgings in the Fort are now just finish'd as to the Brickwork, the roof will also be ready to set up in about a months time, & in two or three months more we hope the whole fabrick will be compleated both withinside as well as without, & that the Charge thereof when it comes before you, will not be thought by Your Honour &c<sup>a</sup>: to be large or in any respect extravagant.

18<sup>th</sup>: The Arrack and Ophium License at Fort Marlborough let this year for Two hundred & five Dollars Pr: Mensem, to Mess<sup>rs</sup>: Savage & Greenslate and the Ophium License at Moco Moco at thirty Dollars Pr: Mensem to M<sup>r</sup>: Charles Gee.

19<sup>th</sup>: We have for the reasons mention'd in our Consultation of the 23<sup>d</sup>: May last, taken Poolo Tecoo (or Ratt Island) into the Companys Possession & orderd M<sup>r</sup>: Jeddere to pay the last Years rent of it into the Companys Cash. We have also let the said Island out to Farm, it was put up at publick outcry, & M<sup>r</sup>: Savage being the highest bidder, hath the Liberty for the ensuing Year to put up Wares for fish and to gather Socalos there for fifty one Dollars, the Year to commence from the 1<sup>st</sup>. June.

20<sup>th</sup>: The Buildings at Moco Moco are in a very sad & ruinous Condition, as both M<sup>r</sup>: Morse and M<sup>r</sup>: Newcome very well know they have been patch'd & propt up from time to time for many years last past, but they are now become so entirely and thoroughly rotten, that they are not any longer capable of being supported that way; as an Instance of which in the month of April last, as Pr: Advice from M<sup>r</sup>: Gee, the Resident there, one whole floor dropt down, when several people were on it & had like to have lost their lives, & what remains is in the same tottering Condition, so that all farther repairs about them is little better than flinging so much money away. M<sup>r</sup>: Gee has frequently wrote to us concerning the aforesaid & earnestly desir'd we should inform Your Honour &c<sup>a</sup>: of these things, and in the most pressing manner to lay before you the urgent necessity of building new lodgings & other necessary



Offices there for the Companys Servants & Military &c<sup>a</sup>. in the room of those that are now become so rotten and useless in all respects, that the poor people who are at present oblig'd to dwell under those roofs, are no ways secure from the inclemency of the bad Air and weather that this coast is frequently attended with, (especially in the night season) neither are they safe in respect to their Lives, the case being really and truly as above represented. We beg leave to observe to Your Honour &c<sup>a</sup>. what the Honourable Court of Directors say in the 31<sup>st</sup>: Paragraph of their General Letter to us by the Enfield, wherein it is mention'd, that although a great deal of their money has been formerly sunk under that article of Building, yet where necessity requires they submit to it. We therefore in this necessitous Case, submit it to Your Honour &c<sup>a</sup>: Consideration, & intreat Your Consent to the removal of those rubbish buildings at Moco Moco. & erecting something plain, tight, & strong, in their stead. We likewise hope you will excuse our dwelling so long on this subject because of the Importance of it, & yet we cannot well conclude this Paragraph without acquainting Your Honour &c<sup>a</sup>: that the Sultan himself, is also an humble Petitioner to You for Your consent in the abovesaid affair, which he is exceedingly Ambitious to see done, & in a Letter to the Dep<sup>y</sup>. Governour he says, as he hath made almost all his Country into a Pepper Garden purely to serve the Company, they will not so much slight him (as he terms it) to let the only Settlement they have in Anakoongey drop & he adds this farther reason for his hopes therein, that he now gives the Company almost as much Pepper P<sup>r</sup>: Annum as all the rest of the Coast, which indeed we must confess comes very near the truth, and that he still promises a Yearly Increase.

21<sup>st</sup>: The Sultan likewise writes to the Dep<sup>y</sup>: Governour as also the Resident of the great use & service it will be, both to the Company & the natives, to have a Pepper Godown at Ippue & another at Bental to receive Pepper in as it is brought down those rivers; the present inconveniency to the Malays for want of these Godowns is, that when they bring down their Pepper to the Quallo, they are oblig'd to lodge it a little in one house and a little in another by which they are considerable sufferers as to pilferidge or else they must stay themselves to look after it and so neglect their Plantations, either of which is a loss to them, and may occasion a disappointment to the Company, but all will be effectually prevented by building a Pepper Godown at each place, which will be giving great encouragement to the Natives, also highly oblige the Sultan, and be a real service to the Company by having the Pepper always ready at hand to be shipt of. The Hon<sup>ble</sup>: Court of Directors mention in the 20<sup>th</sup>: Paragraph of their General Letter now P<sup>r</sup>: Enfield, that they approve very well of the building a Pepper Godown at Laye, & another at Salooma, because they contribute much to the easie collecting in of the Pepper from the adjacent Countrys where they are built, & therein to the more sure dispatch of our Europe Ship. The very same reason holds equally good or rather more strongly so, for building the same conveniency at Bental & Ippue, they being farther from Moco Moco the chief settlement at Northward, we therefore hope Your Honour &c<sup>a</sup>: permission to build them & if so we Promise & Assure You, not a farthing more than what is really and absolutely Necessary, shall be expended thereon. We are humbly of opinion that there will be no occasion to build these Pepper Godowns in that expensive manner, as by the Scheme sent up here by the Sultan & M<sup>r</sup>: Greenslate last Year, a copy of which we inclos'd in our Packet by the George for Your Honour &c<sup>a</sup>: Perusal, but that Bamboo Godowns strengthend with a Timber at each corner, would be very sufficient, and will reduce the Charge of building them within the Compass of a hundred Dollars each Godown.

22<sup>d</sup>. Our Fort Walls being built all with Brick & left quite bare of any covering, we observe the frequent & violent rains beating hard upon them, had occasion'd a greenish moss to grow upon many Parts thereof, which had in some degree impaired & defac'd the brickwork whereupon we thought it very necessary to put a thin chunam Coat all round the Fort, which we accordingly did in June last, it being then fine weather, so that it is well dry'd on & will be a great preservative to the Walls, & remain a lasting Ornament to Fort Marlborough for many Years. It now makes a fine appearance both towards the Sea (especially to the Northward) & for many miles about us on the shore, the charge of which being very small we hope Your Honour &c<sup>a</sup>. will not disapprove of it.

SIXTHLY CONCERNING FACTORS WRITERS OFFICERS & THEIR ACCOUNTS.

23<sup>d</sup>: The Enfield brought here by the Hon<sup>ble</sup>: Companys appointment, six Covenanted Servants, (i.e.) Three Factors & three Writers Viz<sup>t</sup>: Charles Barbut, Edward Latham, Strange Pickard, Thomas Cole, Thomas Saunders, and William Page, which is a very sufficient supply of hands to keep up all our writing business, whereupon we have discharg'd M<sup>r</sup>: John Cary monthly Writer from that Service, The two first of the above Gentlemen we have order'd to assist the Paymaster & Accomptant, and the four last in the Secretaries Office.

[24<sup>th</sup>.] There being at present no Covenanted Servant at Moco Moco but the Resident, we thought it necessary one more should be there to assist him, and in case of mortality to take Charge of the Settlement upon which we have order'd M<sup>r</sup>: Richard Jordan Factor who arriv'd here last Year, to proceed there on the Enfield.

SEVENTHLY TOUCHING ACCOUNTS.

Our last was of the 24<sup>th</sup>. ult<sup>mo</sup>. and

The present Cowle for the Arrack Farm being near expired, we have been looking out for a Farmer to the succeeding Cowle; but the present Farmer having lost so considerably by it, and above 400 Pagodas in bad Debts, as by his List delivered into Consultation, we can yet find nobody here who cares to meddle with it; but Poncala Kistna's Gomasta, says he has made Proposals to his late Master's Brother in Law, Rama Chundrum at Madrass, about it, but that their Losses on the present Cowle shew that they can't give above 900 Pagodas  $\text{p}^{\text{r}}$  an<sup>m</sup>. on the next, allowing that all the Immunities of the present Cowle be continued to them, without the Deduction of selling to the Military, proposed in our Yearly general Letter of the 10<sup>th</sup>. January last. Be pleased therefore to direct whether we shall receive the Gomastahs Proposals for Rama Chundrum if he makes them good, or put it up to Outery on the old Terms, or on those proposed in our said Letter Viz<sup>t</sup>.

“Poncala Kistna Arrack Renter, his Managers here of that Farm often complain of bad Debts, and that if they dont trust poor People they cannot sell any and that they are Lóosers by it; that Cowle ends in July next; and here we humbly beg leave to set forth the Damage this Farm does to our Hon<sup>ble</sup> Masters in their Military; It is true it brings in 1200 Pagodas  $\text{p}^{\text{r}}$  Annum, but those of them who drink this Pariar Arrack, their Distempers and Death are chiefly owing to it; now we would propose when this present Cowle is out to try what the Farmer would give for it, provided he was forbid on a considerable Forfeiture to sell the Value of a single Dram to any of the Military; and for their Provision the Store Keeper should buy good Batavia or Columbo Arrack, and issue it out in certain Quantities, to be sold at such Rates as that certain Profits should arise to the Company thereon; In time it might save many a poor Soldiers Life, and perhaps not cut off much of this Branch of the Revenues.

The new Garden House being now almost finished, and the old House in so creazy and Tottering a Condition that it is dangerous for any Body to go into it, in so much that it may chance to do some Mischief; to prevent that, & preserve all the good Materials it has from being spoiled by the Fall, and keep the Workmen employed, & from deserting us for Pulicherry and other Places whence it would be difficult to recover them, we agreed in Consultation this Morning to have it pulled down, and that what old Materials may be found usefull, should be carefully preserved, towards building the necessary Out Houses that are wanting to make the new compleat with all possible Frugality, and in Order thereto M<sup>r</sup>. Baker who has all

along had Charge of that Building, we ordered to be very circumspect that none of the Materials be embezzled and that the Labourers work their full Time and do their Duty. We hope our Reasons for this Proceeding will be approved, substantial; and, that it may make no wrong Appearance on our Hon<sup>ble</sup> Masters Books, We would propose that the old House be apprais'd by it's present Condition apart from the Garden & the Difference between that, and what it stands at on the Books to this Time, be wrote off and the Cost of the new House when finished, transferred to that Account in Lieu of the old one.

We enclose your Honor &<sup>ca</sup>. an Account Loss of Stores by Waste and Decay for the Year past amounting to Pagodas 193.24.37 with the reported survey of them and pray your Permission to write them off to profit and Loss, and sell the Gun Carriages at Outery for what they will fetch.

The 18<sup>th</sup> Inst<sup>nt</sup>. the Cossimbuzar, and George Sloop arrived here with your Honor & c<sup>as</sup>. Favor of the 23<sup>d</sup>. ultimo, and imported 15000 Pagodas, 4000 Rupees and Packing Stuff for Madapollam, and sailed the 22<sup>d</sup>.; I shall do my utmost Endeavours to accomplish my promised Number of Bales, but there can be no certainty in calculating what Number may be procured, now we trade in so confused a Manner, as is between Madapollam and this Place; and I do not well see how M<sup>r</sup>. Graham can avoid putting his Money out in some parts of this Country, to meet with any tolerable success, but he extends it to too great a Length: Madapollam was equal in Goodness of Trade to this eight or ten Years ago, but since that Rajah has been turned out, the Moors having Possession, and the Numbers of Times it has been in the Hands of both Parties, has been the Occasion of almost every Body's leaving it; there may be some Business done from thence but not enough to answer the Charge of a Factory, especially as I begun to have the Cloth from that Country a few Months before M<sup>r</sup>. Graham arrived, and should have been very successfull this Year, but now I have no Cloth from thence

The Palmeiras are wanted to cover the new Brick Godown; The Bricklayers I have now employed, to make thirty Brick Pillars, for the old mud-Wall Godown, which, with giving a good Repair to the Top, will be a very serviceable Godown, to put the Cloth under the Washers Hands, for a vast many years.

I am in great want of Nails for the Top of the new Godown, and Iron Bars for the Windows, and one thousand Quills, I was in Want of Packing Rope, but that belonging to Madapollam being landed here, I can't see how he will be able to have any of it sent him.

I am very glad my Honble Masters are satisfied with my Endeavors in 1731; I shall always do my best to assure them and you, I am with due Respect

Recommendation in Relation to the Investment, and it is with the greatest Pleasure Imaginable we observe our Honble Masters Approbation of our Management in the year 1731, and though their Notice of our Performance then is undoubtedly a very great Encouragement, yet we beg leave to assure your Honor &<sup>ca</sup>. that we have continually their Interest nearest at Heart which we hope this Year (unforeseen Accidents excepted) will sufficiently Prove.

HONBLE SIR & SIRS

We have duely perused your Favor of the 12<sup>th</sup>. Ins<sup>mt</sup>. with Regard to the Arrack Farm, to which all we can say is, here are no little Bouticas set up near our Bounds more than what have ever been within any of our Memories, and they are but few; and our Military cannot go so far for a Dram, except a few Topasses belonging to the out Guards, which is very insignificant to the Revenues, nor did we ever hear it complained of by the Arrack Farmers or their Deputies, as a Reason for depreciating that Farm; all that we ever could hear from them was, that the lost from the Beginning, having given too much for it at first and that they were obliged to trust poor indigent People whereby the contracted bad Debts, a List of which they shewed us, amounting to near Pag<sup>s</sup>: 500, which we promised them our Assistance to recover what was possible, but they are most or all dead and gone; and they have been always forced to send to Poncala Kistnah, their Principal at Madrass for Money, to make up the Deficiency of their Rent here, otherwise they could not have carried on their Business; But Poncala Kistnah being lately dead, who they say lost considerably by it, these his Gomastah's or Agents say they cannot undertake it without an Abatement of Pag<sup>s</sup>. 300  $\text{R}$  Annum, and we know not of one Person here, besides themselves that is acquainted with the Business.

We have given publick Notice by the Beat of Tom-Tom and Notes affixed to all the Gates, that it is to be sold on Monday the 25<sup>th</sup>. Inst<sup>mt</sup>. at publick Outcry to the fairest Bidder, and if it will not fetch the same as before, we shall buy it in on the Company's Account, and apoint some Persons to look after it, according to your Directions, and wait your further orders.

We had Information a Day or two ago that a Country french Ship called the St. Pedro was to sail for Bengall with the following Cargo.

We herewith send our Account Current with your Presidency & also our Accountant's Remarks, on your Accountant's Letter; We cannot alter the stated Rules of accounting with your Presidency, till our Honble Masters order otherwise.

1735

White which is an ample supply for the present year we sent the whole quantity to Moco Moco & y<sup>e</sup>. other Ports of Annak Soongey for payment of Pepper. According to contract we likewise receiv'd sundry other wares & stores by the same conveyance the whole by invoice amounting to five thousand four hundred forty six Pag[odas] [...] thirty Cash & over [...]

By the [...] Fort S<sup>t</sup>. George we rec<sup>d</sup>. on the Honble Comp[any's] Acc[ount] Sixteen Coyan three hundred Bamboos of Salt w<sup>ch</sup>. we paid the Cap<sup>t</sup>. for the usual rate of \$ 25 twenty five  $\text{P}$  Coyan as  $\text{P}$  order from the President [&] Council of Fort S<sup>t</sup>. George in their Letter p<sup>r</sup>: said [...] April last.

The fifteen Chests of [...] the Lyell came Safe on shore & were [...] weighed in the presence of Cap<sup>t</sup>. Small & were e[...]ly right after which we counted them over & made [the] Number of Doll<sup>rs</sup>: to be Sixty thousand two hundred & [three] Doll<sup>rs</sup>: & a half \$ 60203.2.-, which is accordingly brought to Account our former Cash being at an end when the Lyell arrived made the Supply most seasonable & as it will be very Sufficient also to answer all your Hon<sup>rs</sup>: demands on this Coast for more than one year we humbly thank your hon<sup>rs</sup>. [for] this [ample] Supply which shall be husbanded with all the Honesty & frugality that your hon<sup>rs</sup>. have recommended to us.

### THIRDLY INVESTMENTS, FOURTHLY COUNTRY GOVERNMENT.

By enterposing with our advices & authority by preventing in their first attempts that way the Pangarans & others principal Governing People in this Country from quarelling & destroying each others plantations w<sup>ch</sup>: is the [Common] consequence of such quarrells we have thereby maintain'd a General piece & tranquility throughout the Country w<sup>ch</sup>: we doubt the Continuance of the fruits of w<sup>ch</sup>: peace your Hon<sup>rs</sup>: will find this year on the Ship Lyell we hav<sup>e</sup>: Shipt on board her five hundred & eighty Ton of Clean Garbled Pepper w<sup>ch</sup>: was all conveyed on board by the Comp<sup>ys</sup>: own boats from this Place without any further Charge, We wish your Hon<sup>rs</sup>: a good [...] for the [...] & hope that this Ship together with [...] & enfield w<sup>ch</sup>: we dispatch'd the two [last year] [...] same manner will in some measure retrieve the Credit of this Settlement & convince your Hon<sup>rs</sup>: that our utmost endeavours are not wanting in Order to promote & improve the Comp<sup>ys</sup>: Interest on the [West Coast] of Sumatra.

[The Invoice and] Bill of Lading for the above Pepper [and] [...] as also for 1953 Gall<sup>s</sup>: of Plantation Arrack [...] S<sup>t</sup>. Helena being inclos'd in our Packet we [beg leave] to refer your Hon<sup>rs</sup>: thereto.

We [humb]ly thank your Hon<sup>rs</sup>: for the Supply of Military by the Lyell we sent by her Six Soldiers to Moco Moco & four more, who have been here a great while & have petitioned [*sic*] to go home are discharged & our Garrison Consists of one hundred & twenty five men white & black w<sup>ch</sup>: is a very Sufficient Strength but this last year

has prov'd as much [more] Sickly time than we have had here of late years & still continues so thirteen of our Military men have died since the Harrington left us ☞ List in the Packet & twenty are now in the Hospital. We therefore must pray your Hon<sup>rs</sup>: to send us a Supply of Military by the next Ship to keep up our Present Number.

In the month of June last one of our Dalloos rec<sup>d</sup>. a Letter from a pangaran at Bantam w<sup>ch</sup>: he communicated to the Dep<sup>ty</sup>: Governour intimating that the Sultan of Bantam was order'd by his Masters to enquire in an extra-ordinary manner concerning your Hon<sup>rs</sup>: Settlement of Manna on this Coast whether it belong to him or not if it did he must take care to recover it from the English & it was added that a party of men from Bantam were order'd to join another party of Malays at Lampon in order to effect this. This report was confirm'd by [the] Noquedah of another prow who arriv'd here [...] hereupon we thought it highly expedient to be rightly inform'd concerning the truth hereof & in order to it we sent Bangsaradin to Manna directly to enquire into this affair & advice the pangarans there & the proateens of Cavour immediately to send out People to the Southward for information which being [done] a letter came from Bansaradin the latter end of July advising that he heard of three Panchalons that were at a place to the Southward call[ed] Samancal but he then question'd the Truth of that report however on the tenth of August came another Letter from him by his own Servant wherein he positively assures us one of those panchalons was seen by his man at Tangga & that she had thirty men with firelocks & lances belonging to her, & that five Boats more of the same sort were at a place call'd Marapoayang within a days Sail of Manna but the Contents of this letter taken notice of & our Resolutions thereupon enter'd at large in Our Consultations 11 August we referr your Hon<sup>rs</sup>: thereto & hope our proceedings in that affair as they were ground'd upon repeated assurances that Manna was design'd to be taken from us will meet w<sup>th</sup>: your approbation.

Our Party of men according to Order of Consultation proceeded on their March to Manna the 13 Aug<sup>st</sup>: and stay'd their about eighteen days but no enemy approaching an [*sic*] we receiving information of Boats of the above Nature & equipment usually come once in two years or thereabouts to receive Pepper at Poolo Pesong & parts adjacent w<sup>ch</sup>: being all to the Southward of the Company's bounds & our design being to act only on the Defencive part had no business to go after y<sup>m</sup>. & therefore recalled the Party who return'd to Marlbro' the 16<sup>th</sup>: September [...] living all quiet & well in that part of the Country [w<sup>ch</sup>:] we believe will continue in the better Order by reason of this Expedition [*sic*] for although our Men had no opportunity or occasion to enter upon any Military engagement yet it will have this good effect as to convince the Natives that we are both ready & able to assist & protect them against theirs & the Companys Publick Ene [my] so to reduce them if they are troublesome themselves.

We would only observe from the foregoing that thô these boats did not think fit to come to Manna w<sup>ch</sup>. might be occasion'd by our timely sending there yet they being armed in the manner before mentioned look'd more like a Warr like atchievement than merely to carry on trade w<sup>th</sup>. the Malays tho' they thought fit to give it out that to be their only design. The Chinamen we sent for from Java the better to Carry on the Coffee Plantation came accordingly last year & we took two into the Comp<sup>as</sup>: Service & gave them twelve Doll<sup>rs</sup>: a month each to encourage their industry they began a Plantation of Coffee near the Comp<sup>a</sup>: Sugar Plantation but after about three months experience they were found to be Idle Lazy fellows & meer pretenders to acknowledge in that affair we therefore where obliged to turn them off to same twenty four Dollars ☞ Month & that Young Garden hath since been looked after by the People belonging to the Sugar Plantation some of the trees are dead but there are a great many that are in a thriving Condition & we continue to give out to the Malay's Coffee Berrys & plants as we can get them that are fit for Growth so that the business of Coffee goes on as fast as we are able to forward it, & the Malays are as ready & willing to employ themselves that way as we are to have them.

We thank You[...] for leaving the care of the Surveys to our management & beg leave to assure you that they shall be perform'd w<sup>th</sup>: all the diligence & exactness that can be.

It is likewise a great Pleasure to us to find your Hon<sup>rs</sup>: so well satisfied w<sup>th</sup>: the affairs of Annack Soongey w<sup>ch</sup>: are still very well managed & lookt after & we have this Season [received] from thence Seven hund<sup>d</sup>: forty Seven Baharrs of Pepper w<sup>ch</sup>: intitles the Sultan to your Hon<sup>rs</sup>: present of fifty Dollars this Settlement of Moco Moco shall be sure to be supply'd with all the necessary assistance that they want or we can give them at any time from hence & no encouragement shall be wanting both to the people of that Country & this to go briskly on w<sup>th</sup>: their Plantation.

We are very glad your Hon<sup>rs</sup>: approve of our assisting the Dutch Ship two years & are persuaded the Hon<sup>ble</sup>: Comp<sup>as</sup>. Shipping that have touch'd at Batavia since have been the [better] treated on that acc<sup>t</sup>: about three months ago a Dutch Ship call'd the Terhorst arriv'd in our Road from Negapatam & had myn heer Pla the late Gov<sup>r</sup>: of that Place on board & his wife & Daughter who are all invited & entertain'd on Shoar the Ship had been five months in her Passage & was in great want of Water Wood rice &c<sup>s</sup>. all w<sup>ch</sup>: we Supply'd them w<sup>th</sup>: and after about twenty days stay here the [sic] Sail'd for Batavia where they were bound very thankfully & well satisfied.

The Plantation affairs from August 1733 to the end of August 1734 went on very successfully & there was made in that time 6875 Gallons Six thousand Eight hund<sup>d</sup>: & Seventy five Gallons of good Arrack about two thousand Gallons of w<sup>ch</sup>: we have now Shipt on board [the Lyell] for S<sup>t</sup>. Helena the beginning of September a Stop was made for want of ripe Canes w<sup>ch</sup>: continued three months but they are now at work again whilst there was no Canes fitt to cutt the Slaves were employ'd in making a very large new plantation w<sup>ch</sup>: will be a means to prevent these breakings off for the future we have this year greatly reduct [sic] the Charge of the Plantation by dismissing old Cap<sup>t</sup>: [...] the distiller also the Chinasugar boiler & the [M]alabar Carpenter who alltogether rec<sup>d</sup>. twenty nine Dollars  $\text{p}$  Month w<sup>ch</sup>: reduction of Charges & hav<sup>s</sup>: nevertheless made more Arrack than in any Year before the Plantation has this last year deducting all the Common Standing Charges of it Clear upwards of two hundred & fifty Doll<sup>rs</sup>. as thus the monthly Charges is Dollars one hundred & Seventy two Sucas or \$ 1290 twelve hundred ninety Dollars  $\text{p}$  Annum for Wages & maintenance all the Slaves & debtors employed in that work & the Arrack produced within the year above mentioned is 6875 Six thousand Eight hundred Seventy five Gallons w<sup>ch</sup>: at 36 Dollars  $\text{p}$  Leagure of one hundred & sixty Gallons 160 Gall<sup>ns</sup>. amo<sup>ts</sup>: to \$ 1546 one thousand five hundred forty six Doll<sup>rs</sup>. & gives the ballance abovesaid.

#### FIFTHLY FORTIFICATIONS BUILDINGS REPAIRS & REVENUES

There has not been any money expended on the foot itself this Year & the new row of buildings within the fort for the Covenanted Servants is handsomely compleated & inhabited & there are new buildings necessary that we hope of but the Hospital except the increase of Pepper should bring us under a necessity of Enlarging the Godowns for the reception of [the Co]modity the whole am<sup>t</sup>. for Repairs last year is \$ 837 eight hundred thirty Seven dollars but the same was unavoidable & a larger expence must have ensued had those repairs been neglected we therefore hope your Hon<sup>rs</sup>. will not be displeas'd at this Article.

So large a quantity of Tarrass as mentioned in y<sup>e</sup>. Storekep<sup>rs</sup>. list by the [Enfield] was occasion'd by a misunderstanding between [him & the bri]cklayer but the quantity your honours have sent us is [very] sufficient the use it is intended for is to secure the [roofs] of the Building where the Soldiers lodge as also the Gunroom & Armory w<sup>ch</sup>: are all flat on the Top & our Chinam will not keep the rain from soaking through w<sup>ch</sup>: this Terrass we are assur'd will.

The licence for Arrack sold this year at Public Outery for one hundred forty five Doll<sup>rs</sup>.  $\text{p}$  month to M<sup>r</sup>. Greenslate the Ophium Licence for ninety Six Doll<sup>rs</sup>.  $\text{p}$  month to M<sup>r</sup>. Jeddere the opium Licence for Moco Moco for thirty Doll<sup>rs</sup>.  $\text{p}$  month to M<sup>r</sup>: Greenslate and Poolo Tecus (or Rat Island) for fifty one Doll<sup>rs</sup>.  $\text{p}$  Annum to M<sup>r</sup>. William Coles w<sup>ch</sup>: was the utmost they would then sell for & is in all fourteen Dollars  $\text{p}$  month short of what they sold for last year Your Hon<sup>rs</sup>. take notice in the 24<sup>th</sup>: Para of General Letter  $\text{p}$  Hertford that by our Acco<sup>t</sup>: for the Year 1732 there appears but \$ 122 one hundred & twenty two Doll<sup>rs</sup>. gaind on the Article of Salt it is very true there appears no more at the foot of that Account than one hundred & twenty two Doll<sup>rs</sup>: but that is the Profit arising only from the sale of salt at twelve Bamboos  $\text{p}$

Doll<sup>r</sup>: w<sup>ch</sup>: is not a fifth part of the real gains the Honble Comp<sup>a</sup>: receives from y<sup>e</sup>. Article of Salt for the year 1733 your hon<sup>rs</sup>: will please to observe by our Books that year y<sup>t</sup>: \$ 253. 3. 27 is made gain'd by Salt but that sum is farr Short of the real gains on that Comodity in 1733, because by Salt the Charges of the [settlement] maintenance is very greatly reduc'd both here & at the Plantation as for Instance of the Rice delivered them Monthly was to be purchas'd at the price it bears in an avariage [*sic*]. all the Year round w<sup>ch</sup>. is about twelve Bam<sup>a</sup>.

We have receiv'd your Favour of the 18<sup>th</sup>: Ins<sup>t</sup>: and the several peices of Cloth return'd us w<sup>ch</sup>: we have looked over & Compar'd w<sup>th</sup>: the Contract Musters & are sorry to observe some of the Peices are so bad, th<sup>o</sup> we really are of opinion Some others of them are hardly anything inferiour to our Musters; Our Sorters beg leave to assure your Hon<sup>rs</sup>: & C<sup>ts</sup>. that they always endeavour to Sort to the best of their Judgement impartially between the Merch<sup>ts</sup>: & the Company that it does sometimes happen that a Peice or two may at the end of a Sorting be wanting to make up a Bale & be taken out from Cloth of a Different Sortment & this might happen more often in [the late] frequent Sorting on the Dispatch of the [...] They believe the main of the Cloth sent up lately will not be found to be so bad as the Peices return'd us, And a few indifferent peices may by oversight or mistake of the Serv<sup>ts</sup>: in the Warehouse be put into the Bales Which can't always be prevented. They however promise they will be more particularly Carefull for the future.

We are Sorry to find that the Curing of the [cloths has been] much complain'd of that the whole par[ts have to] be rewashed; & on this head we beg leave to re[mind] that the Washing here was never thought equal to that of Madrass. That we think it impossible it should be so, Our Cloth when Conjeed being laid out on the Grass for want of Sand near the Washing Places by w<sup>ch</sup>: means it will often be discolour'd. Our beating Godowns are dirty Tyled places where the Cloth cannot possibly be kept so clean as at Madrass (though we shall endeavour now to remedy this inconvenience by hav<sup>g</sup>: them Pav'd & the Roofs Cover'd w<sup>th</sup>: flat Tyles) The Washers we are forc'd to employ cannot possibly be expected to know their Business so well as when a large Number of them were constantly kept in employment for many years together, but when the Investment here dwindled to a few Bales y<sup>e</sup>. best of the Washers for want of employ where forc'd to leave the Place, and it [will be] always found difficult to get Numbers of good Workmen of any kind brought in Just at a time when they are wanted. When the Dep<sup>ty</sup>: Gov<sup>r</sup>: arrived here there were but eighty Washers employ'd & for Several months this last Season We had four hundred constantly at Work on the Comp<sup>ys</sup>: Cloth of whom it will Necessarily happen there must be Several not well used to the Business but they were the best to be got & it was w<sup>th</sup>: much trouble that we got them. We are however of Opinion the Cloth in general has been washed as well as it us'd to be here except some that was made up at the time the George was filling here & then we were forc'd to put up Cloth not quite so well Cured as it should be for fear the Ship should wait for the Goods & possibly some of the last Parcel sent up might be a Part of them: And this in good measure happen'd by our not h[aving gu]nys to make up the Bales w<sup>ch</sup>: occasion'd a large [amount] of Cloth ready Cured to lie loose in the Godowns [...] Packing Stuff to Embale w<sup>th</sup>..

and when that Co[...] to send the cloth back to be rewash'd time en[...] the Ship & we thought ourselves obliged rather than wa[...] for her to take in what was any thing tolerably Cured [and] We beg leave also to Say that some of the Peices of Cloth now returned us do not seem to us, much defective in the Washing & the Merch<sup>ts</sup>, alledged it will be ruinous to them if [they] be obliged to rewash such Cloth.

We have Shewn our Merch<sup>ts</sup>, the Peices of Cloth sent us back and acquainted them with what Yo<sup>r</sup>. Hon<sup>r</sup>. & c<sup>a</sup>. have wrote us on this Occasion : In answer to it they assure us they shall be rather Loosers than Gainers by this Investment, That the Salem Cloth brought in by them is y<sup>e</sup>. same as what brot in by Andeapa & bought at the same Place & at the same Prizes with his & for Conformation of this they desire a few Bales of his & their Cloth may be open'd & Compar'd y<sup>e</sup>. upon a Calculate of the Prices of the Several Numbers it will be found that their Cloth does not exceed the Prices given Andiapa after deducting 2½ % Cent Land Custom & Dus[t]ore, That Andiapa delivers in his Cloth Brown w<sup>ch</sup>. after it is measur'd he has nothing more to do w<sup>th</sup>. But they are oblig'd to deliver Theirs Washed & the Washing has this year cost them about fourteen Madrass fanams more than the Company allow them for it, A great deal of the Cloth has been Torn at the Washers & some Stolen, large Quantities have been returned upon them for being ill Washed & the Rewashing has Cost them above a Pagoda a Corge ; About forty Bales of Salem Cloth have been taken into Ordinary & some turned out, Besides they are obliged to advance Money to the Washers who are in their Debt about two hundred Pag<sup>s</sup>. which they will never be able to repay them ; These Inconveniences [and losses] they represent themselves liable to which [ . . . ] entirely Clear off.

For the long Cloth Ordinary they say the [ . . . ]ry Difficult to procure this Sort of Cloth Th[ . . . ]atch at Porto Novo Pay Pag<sup>s</sup>. 38. 16. ¾ Corge for wo[ . . . ], that they have deliver'd in only Seventy four Ba[les], of w<sup>ch</sup>. forty were taken out of the Salem Cloth & thirty four Bales are all that are made up out of the Quantity of Sixty or Seventy Bales brought in by them & the [rest] being turned out will occasion a Considerable loss to them.

The Salampores they can Say little in Excuse of, It is certain what they have brought in latterly has been very bad as we have already advis'd your Hon<sup>r</sup>. & c<sup>a</sup>. much the greater part has been turn'd out, & but a little taken to N<sup>o</sup>. 2 & the N<sup>o</sup>. 3 there being no Muster of, The Sorters apprehended it to be much y<sup>e</sup>. same as had been all along taken in to that Number, but in an heap of bad Cloth they Say they might be something Mistaken & are very Sorry it Should have happen'd so They observe this Cloth has for Several Years past been made of a Coarser thread than the Musters though it has not been before found fault w<sup>th</sup>. & such a Sort as the Old Musters are of, is not we believe now made in the Country.

After the Merch<sup>ts</sup>. had represented to us what we have above acquainted Your Hon<sup>r</sup>. & c<sup>a</sup>. with We then propos'd to them the entering into new Contract for the ordinary & blue Cloth agreeable to your Directions in your [ . . . ] Letter, But they are so much terrified with the Complaints about their Cloth & particularly about the Rewashing the white parcel last sent up that they now seem very unwilling to enter into any Contract at all, And the most we could bring them to after a long Discourse with them, Was, That in Case they might be permitted to deliver in their C[lot]h Bro[wn] as Andiapa does they would undertake to [ . . . ]good for a quarter of a Pagoda a Corge less in Price [ . . . ] might be assured they should be no L[ess] act they were willing to enter in [ . . . ]se their utmost endeavours to bring in the b[ . . . ]ales can, & of the higher Numbers ; But without [any] such assurances They say they can't venture upon [Bonds] They are very ready to serve the Company in bringing in Cloth though they don't get a fan<sup>m</sup>. by it But that they are Poor men & if any large Quantity of Goods [are] returned upon their hands, as it will be difficult to find a Vent for them here, it will end in their Ruin : We have thus laid before your Hon<sup>r</sup>. & c<sup>a</sup>. what our Merch<sup>ts</sup>. desir'd we should communicate to you : We will try yet whether we can be able to prevail upon them to enter upon a new Contract. Ins<sup>t</sup>. & are sorry to find we lie under your Displeasure for Omitting to acquaint you in what manner we shewed our Dislike of the Merch<sup>ts</sup>. Usage [it was some] time that we communicated to you what they desired [to] represent in our last General Letter. However w[e...], as on many many Occasions before wanting [. . .] know that these Complaints of theirs pr[oceed] from their own negligence & particularly [. . .] he Torn Cloth & what they have been obliged [. . .] & though this has been so often inculcated on [ . . . ] always assure us, That they take all the Care they can & do constantly Inspect the Cloth at the Washers, and notwithstanding This, Several of these Accidents will often happen.

We acquainted the Merch<sup>ts</sup>. with what your Hon<sup>r</sup>. &c<sup>a</sup>. Advise, that many Peices of their Cloth lately sent up were found to be torn & some Rotten; And they declare the Cloth when deliver'd the Washers was good & that This must have happend while it was in their hands, & all that they could perceive to have been damaged or torn they took out and have now a great parcel of it by them. We beg leave also to assure your Hon<sup>r</sup>. &c<sup>a</sup>. That we are not wantin [sic] Ourselves in our Care to have the Cloth overlooked before it is Conjeed & all torn Peices turned out, but by the distance of the Washing Places, the badness of our black Servants who are not comparable to

those of Madrass, and the few Covenanted Servants we have to send thither, we have not been able to prevent Damages, Tearing & ill Washing so much as we could wish : and

Though our Polygar out [*sic*] to have paid for all Cloth Stolen Yet our Merchants tell us he is still Indebted about a hundred Pagodas to them on that Acc<sup>t</sup>. and indeed in the late dear times the Fees receiv'd by him were but barely sufficient to pay the Taliars ; and the new Polygar late [sent us] from Worriarpollam proves as Idle & worthless a fellow as he we had before by which means many Robberys are constantly committed, But we shall take Care to stop out of his Fees after his People are [paid . . . ] gradually so far as to Pay what he owes on this [Acc<sup>t</sup>. . . . ] means put an end to this Complain<sup>t</sup>.

We have been trying again to bring [ . . . ] a new Contract, but though they tell us they [ . . . ] bring in more Cloth than last year of the [ . . . ] yet they Still Complain so much of their [ . . . ] by the Curing the Cloth that we cannot Ye[t . . . ] hem to undertake a new Contract otherwise than on the terms mentioned in our last.

The Sloop Rama is not yet Arrived here.

11. The hopes we had of being able to withdraw the Trade from Bimblepatam to this Place we now find to be impracticable; that Town is rented from the Rajah who has possession of all the Country round us w<sup>ch</sup>: said Town Rent is let annually to the best bidder therefore encreases; Our Town is rented from the Nabob at the certain Rent, which neither Rises nor falls, & should the Rajah find that the Revenues of Bimblepatam Should Sink by the flourishing of Vizagapatam, 'tis certain that he would impede Grain comming in from the Country; an [inst]ance of this kind happen'd very lately of some People which [came] out of the Country & were willing to Purchase our Salt, before [some] which belonged to a Renter under the Rajah close to our [Bounds] who told the Buyers publicly that if they did not [...] some heaps of his likewise they should not pass the Junian [...] [that] they had bought of us alone.
