ORDER THEREON.

21st October 1869 N^o 1450.

Hindrances having been found to exist to the immediate acquisition of the lands and buildings referred to in the annexed Declarations by purchase from the parties interested therein, the Governor in Council resolves, under the Provisions of Section CX XVIII of Act No. XIV of 1856, and Section II of Act No. VI of 1857, to order that the said lands and buildings be taken possession of on the part of Government, and applied to the purpose for which they are needed, leaving claims for compensation for the lands and buildings to be determined as provided in the said last mentioned Act, and, further, to appoint the Collector of Kannool — — — in communication with *the Executive Engineer of the Range*, to carry this order into execution, and to execute any award, and to do all things necessary for completing the business of taking and paying for the said lands and buildings, and for settling all disputes concerning them.
